I understand that the purpose of this Agreement and Liability Release (this "Agreement") is to exempt, waive and relieve Christopher A. Having read the outline and disclaimer, I fully understand the nature of Sports Academy's lessons and team associations (each, a "Lesson", and collectively, the "Lessons", each, "Teams"), and I understand that by signing this Agreement, the above referenced parties are not held liable for any injuries that may result in connection with the above-named child's attendance or participation under the Sports Academy. I further understand that if the Lesson Instructor or Coach deems medical attention is necessary for the above-named child, I will be solely responsible for the payment of all costs incurred in connection with such medical attention.

To the best of my knowledge, the above-named child is physically fit and able to participate in the Lessons and Teams. I recognize that it is possible that such child's attendance at the Sports Academy and/or the child's participation in a Lesson or Game could involve risks to the child including, but not limited to, **bodily injury, partial or total disability, death, and other damages**, known or unknown, and that I have full knowledge of aid risks. I acknowledge that these risks and dangers may be caused by the above-named child's own negligence or misconduct or the negligence or misconduct by others, including the above referenced parties. These risks and dangers include, but are not limited to, risks and dangers arising from the use, handling, throwing and hitting of baseballs and softballs and the use and swinging of baseball and softball bats and the use of any and all equipment used during Speed Training, Lessons and Games by the above-named child and others. I further acknowledge that there may be risks and dangers described throughout this Agreement, the outline and the disclaimer, including those caused by the above-named child's negligence or misconduct and/or that of others, and those risks and dangers not known or reasonably foreseeable at this time, are included in the waiver, release and relinquishment discussed herein. Nonetheless, it is my desire for the above-named child to attend the Sports Academy and participate in the Lessons and Teams.

I understand the nature of the Lessons and Teams, and I hereby release the above referenced parties from any and all claims, liabilities, suits, actions and proceedings, directly or indirectly arising from, out of, or related to the Sports Academy, Lessons or the Teams, including without limitation, any claim or cause of action (including any cause of action based on negligence) directly or indirectly arising from, out of or related to the performance, or failure to perform, maintenance, supervision, inspection or control of the Sports Academy premises and for failure to warn of dangerous conditions existing at such premises or for negligent supervision or instruction by the above referenced parties. I acknowledge that I, on behalf of the above-named child and myself, am freely and expressly assuming and accepting any and all risks of property damage, personal injury and/or wrongful death.

I/We also understand that our/my child can be removed from the league, premises, camp, class or any related activity by the directors for unsportsman-like conduct, immoral activity, unethical play, drug or alcohol abuse, and any other activities that are not construed to be in the best interest of the team or any of its players, or the SPORTS ACADEMY. I/We also understand that any and all sign up fees received by the SPORTS ACADEMY shall not be refundable, and become a part of the SPORTS ACADEMY.

By signing this release, it allows for the SPORTS ACADEMY to post any pictures from any camps, clinics, lessons or events run by the SPORTS ACADEMY or any partners or colleagues and affirms that he or she has read the above carefully and fully any camps, clinics, lessons or events run by the SPORTS ACADEMY.
